## **Wandle LETS Account Holder's Agreement**

1. Wandle LETS is a non-profit organisation which provides an information exchange and recording service which maintains a system of accounts for trading in local currency called ecos
2. An eco shall be considered equal to £1 sterling. The eco exists only in the accounts entries. It has no surrender value in sterling, moreover it never leaves the network and no coin or notes are issued. Ecos are created by members in the act of providing goods or services to others in the network
3. All accounts start at zero, but an opening credit may be issued to new members at the discretion of the management group
4. No interest is charged or paid on any balance
5. Account holders shall be willing to consider trading wholly or partly in ecos, but only the eco portion will be recorded in the network. There is no obligation to trade. Wandle LETS does not set prices – these are set by members when they trade – but the management group may establish a base rate that can be used as a starting point or suggested level
6. Ecos will be transferred from one member to another on the authority of the member receiving the goods or service, by way of an eco-cheque or verifiable e-mail message forwarded to the registrar/administrator. Any transaction considered to be inappropriate or unlawful will not be recorded
7. Any account holder may know the balance and trading activity of any other
8. Accountability for taxes incurred by account holders is the obligation of those involved. Wandle LETS does not collect taxes, and will not be liable to share information with taxation authorities
9. Wandle LETS makes no warranty or gives no undertaking as to the value, condition, or quality of items traded or services rendered
10. Wandle LETS will take all reasonable steps to safeguard confidential information it holds, as required by the Data Protection Act
11. Wandle LETS may act on behalf of its members to seek explanation, payment or satisfaction from any member whose conduct is considered to be contrary to the interests of another member or other members, as a last resort, removing such a member from the network
12. Any member leaving the network agrees to use their best endeavours to clear any debit balance, and agrees to release any unused credit balance back to the system
13. All members are deemed to have read and accepted the Rules and Constitution and the Equal Opportunities Policy of Wandle LETS
14. All members agree to their details being recorded on computer, and to relevant information being shared with other members, in harmony with the principles of the Data Protection Act
